15	WHEREAS, the Commissioner of the State of Nevada, Department of Business and Industry,
16	Division of Mortgage Lending ("the Commissioner") having been statutorily charged with the
17	responsibility and authority to administer and enforce Chapter 645B of the Nevada Revised Statutes, NRS
18	645B.010 et seq. ("the Statute"), and Chapter 645B of the Nevada Administrative Code, NAC 645B.001
19	et seq. ("the Regulation") (collectively, "the Act") governing the licensing and conduct of mortgage
20	brokers and mortgage agents doing business in the State of Nevada; and,
21	WHEREAS, on July 11, 2019, the Commissioner issued to BENEDICT ANIL PRASAD ( "the
22	Respondent"), NOTICE OF INTENT TO ISSUE AND ENTER FINAL ORDER REVOKING
23	MORTGAGE AGENT LICENSE, IMPOSING ADMINISTRATIVE FINES, AND REQUIRING
24	PAYMENT OF INVESTIGATIVE COSTS AND NOTICE OF OPPORTUNITY FOR HEARING (the
25	"Order") attached hereto as Exhibit 1 and incorporated herein by this reference; and,
26	WHEREAS, the Order imposed upon Respondent an ADMINISTRATIVE FINE in the amount
27	of \$25,000.00; and,

1	WHEREAS, the Order further assessed upon Respondent in the amount of \$2,490.00; and,
2	WHEREAS, the Order, served on Respondent on or about July 11, 2019, advised Respondent
3	that Respondent was entitled to an administrative hearing in this matter if Respondent filed a written
4	request for a hearing within 20 days of receipt of the Order; and,
5	WHEREAS, Respondent failed to exercise his rights to an administrative hearing, timely or
6	otherwise; and,
7	WHEREAS, having indicated to the Division's legal counsel in mid-September of 2019 that he
8	would soon contact legal counsel if he would dispute the Order, Respondent has failed to do so; and,
9	NOW, THEREFORE, based upon the factual findings set forth above and the files and records
10	of the Division of Mortgage Lending, IT IS HEREBY ORDERED THAT:
11	1. The findings of fact and conclusions of law set forth in the Order shall be and hereby are
12	found to be true and correct.
13	2. ADMINISTRATIVE FINES AND INVESTIGATIVE COSTS are hereby issued and
14	entered against Respondent pursuant to the Act as follows
15	a. An ADMINISTRATIVE FINE in the amount of \$25,000.00 shall be and is imposed
16	upon Respondent.
17	b. Respondent is assessed the Division's INVESTIGATIVE COSTS in the amount of
18	\$2,490.00.
19	3. Respondent's license is hereby revoked.
20	4. This Final Order shall be and is effective on the date as issued and entered, as shown in
21	the caption hereof.
22	5. This Final Order shall remain in effect and fully enforceable until terminated, modified,
23	or set aside, in writing, by the Commissioner.
24	6. The Commissioner specifically retains jurisdiction of the matter(s) contained herein to
25	issue such further order or orders as she may deem just, necessary, or appropriate so as to assure
26	compliance with the law and protect the interest of the public.
