17 Respondent's previous non-compliance which was the basis for the Notice; and

18 WHEREAS, Upon further review of this matter the Division has determined that is in
19 the best interests of the parties that the Notice be rescinded; and

20 WHEREAS, The parties agree that the Notice shall be rescinded upon the following
21 terms and conditions:

- 22 1. Respondent shall pay to the Division the sum of THREE HUNDRED FIFTY DOLLARS AND
23 NO CENTS (\$350.00) immediately upon Respondent's execution of this Stipulation; and
24 2. Respondent agrees to fully cooperate with the Division in its resolution of the matter to
25 which the documents pertain.




