The State of Nevada, Department of Business and Industry, Division of Mortgage Lending (hereinafter, the "Division"), having served the Respondent, Alexander Jariv, (hereinafter, "Respondent") on June 15, 2009, with its Order to Cease and Desist and Notice of Intent to Impose Fine and Notice of Right to Request Hearing, attached hereto as Exhibit "1" and incorporated herein by reference, which notified Respondent that a final order would issue in this matter unless, within twenty (20) days of entry and receipt of said Order, Respondent requested a hearing to contest the charges against it, with said request to be made in writing, and;

Said Order having been sent to Respondent via certified mail and regular mail, and received by Respondent on July 3, 2009, and;

Respondent having failed to request a hearing in this matter, and good cause appearing:

1 NOW, THEREFORE, IT IS HEREBY ORDERED that, pursuant to NRS 645B.670 and  
2 NRS 645B.690, Respondent shall immediately **CEASE AND DESIST** all unlicensed mortgage  
3 broker, banker, or agent activity in the State of Nevada. In addition, Respondent will be subject  
4 to the administrative fines, fees and/or costs as set forth in the original Order attached hereto as  
5 Exhibit "1".

6 **IT IS FURTHER ORDERED** that the sum of said administrative fines, fees and/or costs  
7 be paid in full within **thirty (30) days** of entry of the Order;

10 **ORDER TO CEASE AND DESIST AND**  
11 **NOTICE OF INTENT TO IMPOSE FINE AND**  
12 **NOTICE OF RIGHT TO REQUEST HEARING**

13 The licensing and regulation of mortgage brokers and mortgage agents in the State of  
14 Nevada is governed by Chapter 645B of the Nevada Revised Statutes (hereinafter, "NRS")  
15 and Chapter 645B of the Nevada Administrative Code (hereinafter, "NAC"). The State of  
16 Nevada, Department of Business and Industry, Division of Mortgage Lending (hereinafter, the  
17 "Division") has the general duty to exercise supervision and control over mortgage brokers  
18 and mortgage agents, as well as mortgage brokering activity. See, NRS 645B.060(1), NRS  
19 645B.690 (1)(a) and NRS 645B.670. Pursuant to that authority, the Division makes the  
20 following Factual Allegations, Violations of Law, and Order as follows:

21 **FACTUAL ALLEGATIONS**

22 1. On April 27, 2009, the Division commenced a regularly scheduled examination of  
23 Advantage Mortgage and determined Alexander Jariv (hereinafter, "Respondent") engaged in  
24 mortgage agent activities in relation to a mortgage loan obtained by Nam for the purchase of  
25 real property in Nevada, without either a mortgage broker or mortgage agent license.

26 2. Although licensed with the Division until August 24, 2008, Respondent was not  
27 licensed as a mortgage broker or mortgage agent with Advantage Mortgage when he  
28 engaged in mortgage loan activity for the loan obtained by Nam.

1           3. Pursuant to NRS 645B.060, the Division shall "...conduct an annual examination of  
2 each mortgage broker doing business in this state." See, NRS 645B.060(2)(d).

3           4. Pursuant to NRS 645B.060, the Division is charged with conducting "...such  
4 investigations as may be necessary to determine whether any person has violated any provision  
5 of this chapter, a regulation adopted pursuant to this chapter or an order of the Commissioner."  
6 See, NRS 645B.060(2)(c).

7           5. Pursuant to NRS 645B.0127, a "mortgage broker" is defined, in pertinent part, as  
8 "...a person who directly or indirectly... holds himself out for hire to serve as an agent for any  
9 person in an attempt to obtain a loan which will be secured by a lien on real property..." or  
10 "...holds himself out for hire to serve as an agent for any person who has money to lend, if the  
11 loan is or will be secured by a lien on real property..." or "... holds himself out as being able to  
12 make loans secured by liens on real property..." See, NRS 645B.0127(1)(a)(b)(c).

13           6. Pursuant to NRS 645B.0125, a "mortgage agent" is defined, in part, as "...a  
14 natural person who... is an employee or independent contractor of a mortgage broker who is  
15 required to be licensed pursuant to this chapter..." and "...is authorized by the mortgage broker  
16 to engage in, on behalf of the mortgage broker, any activity that would require the person, if he  
17 were not an employee or independent contractor of the mortgage broker, to be licensed as a  
18 mortgage broker pursuant to this chapter..." See, NRS 645B.0125 (1)(a)(b).

19           7. Pursuant to NRS 645B.690, "...if a person offers or provides any of the services  
20 of a mortgage broker or mortgage agent or otherwise engages in, carries on or holds himself  
21 out as engaging in or carrying on the business of a mortgage broker or mortgage agent and, at  
22 the time... the person was required to have a license pursuant to this chapter and the person  
23 did not have such a license... the Commissioner shall impose upon the person an  
24 administrative fine of not more than \$10,000 for each violation and, if the person has a license,  
25 the Commissioner shall revoke it..." See, NRS 645B.690(1)(a).

26           8. Pursuant to NRS 645B.900, "...it is unlawful for any person to offer or provide any  
27 of the services of a mortgage broker or mortgage agent or otherwise to engage in, carry on or  
28 hold himself out as engaging in or carrying on the business of a mortgage broker or agent

1 without first obtaining the applicable license issued pursuant to this chapter..." See, NRS  
2 645B.900.

3 **VIOLATIONS OF LAW**

4 1. Having completed an annual examination and investigated the Respondent's  
5 conduct in this matter and received competent evidence that Respondent provided the  
6 services of a mortgage agent without first obtaining the applicable license by originating and  
7 closing a the mortgage loan for Nam which was secured by a lien on real property, in the  
8 State of Nevada, it has been determined that Respondent did, in fact, engage in mortgage  
9 agent activity in the State of Nevada without a license to do so, thereby violating NRS  
10 645B.690(1)(a) and NRS 645B.900.

11 **ORDER**

12 **NOW, THEREFORE,** pursuant to NRS 622.080 and NAC 645B.340, the  
13 **COMMISSIONER** of the **DIVISION HEREBY ORDERS** that Respondent immediately **CEASE**  
14 **AND DESIST** from conducting activity requiring licensure pursuant to NRS Chapter 645B and  
15 the regulation promulgated thereto.

16 **IT IS FURTHER ORDERED,** pursuant to NAC 645B.340(4), that upon filing a verified  
17 petition with the Division within **thirty (30) days** of receipt of this Order to Cease and Desist,  
18 Respondent shall be entitled to a hearing with regard to the contents of this Order to Cease  
19 and Desist. Respondent is advised, however, that the provisions of this Order to Cease and  
20 Desist are effective immediately upon Respondent being served therewith, whether or not  
21 Respondent requests a hearing.

22 **NOTICE TO RESPONDENT:** If you request a hearing, you are specifically informed  
23 that you have the right to appear and be heard in your defense, either personally or through  
24 your counsel of choice at your own expense. At the hearing, if one is timely requested, the  
25 Division will call witnesses and present evidence against you. You have the right to respond  
26 and to present relevant evidence and argument on all issues involved. You have the right to  
27 call and examine witnesses, introduce exhibits and cross-examine opposing witnesses on any  
28 matter relevant to the issues involved.

1 If the Division prevails at any hearing, it may request that attorney's fees and costs be  
2 awarded pursuant to NRS 622.400.

3 **IT IS HEREBY ORDERED** that pursuant to NRS 645B.750, upon written application to  
4 the Division within **twenty (20) days** of the date of this Order, Respondent shall be entitled to a  
5 hearing with regard to the contents of this Order referenced below. At that hearing, the Division  
6 will seek to:

7 1. Impose a fine of Five Thousand Dollars and No Cents (\$5,000.00) for Respondent's  
8 violations of NRS Chapter 645B, as well as for the Division's investigative costs in the amount of  
9 One Hundred and Eighty Dollars and No Cents (\$180.00), and attorney's fees, if any, incurred  
10 herein, to be proven at the hearing; and

11 2. Require Respondent's payment, in full, of the administrative fine, costs and fees  
12 within **thirty (30) days** of entry of the Final Order.

13 Should Respondent not request a hearing within **twenty (20) days** of the date of this  
14 Order, the Division will enter a Final Order in this matter against Respondent, pursuant to NRS  
15 645B.750(2)

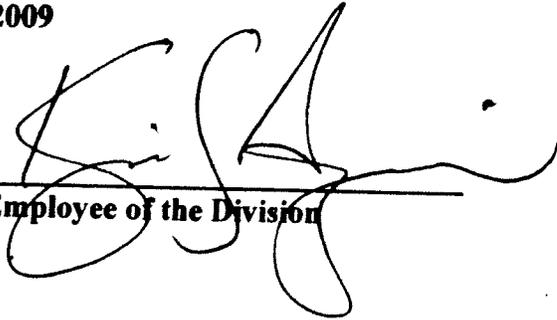

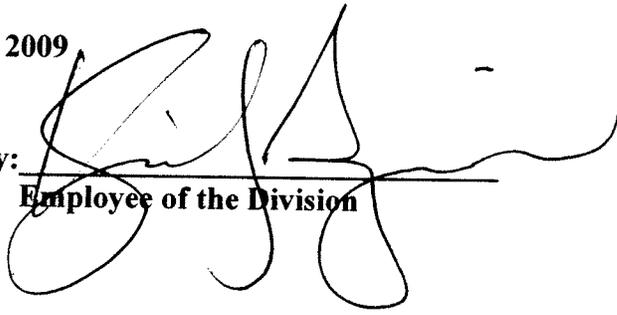
