Notice of Public Workshop / Workshop Agenda NRS 645B and NRS 645E Division of Mortgage Lending November 9, 2022

The purpose of the workshop is to solicit comments from interested persons regarding the Division's proposals to amend the regulations subject of NRS Chapters 645B (governing mortgage brokers and mortgage agents); and 645E (governing mortgage bankers). In particular, the Division seeks input from interested persons to assist in its determination as to whether or not the proposed regulations are likely to impose a direct and significant economic burden upon a small business, or restrict the formation, operation, or expansion of a small business.

As generated from, or in compliance with revisions made to the Nevada Revised Statutes ("NRS") by the Nevada Legislature in 2017, the Division has drafted proposed regulations as follows:

- With respect to the Division's regulatory revisions to the *existing* language of NRS 645B and NRS 645E, these are based upon the statutory changes to NRS 645B and NRS 645E, resulting from the enactment of by AB 468, effective October 1, 2017, which granted the Commissioner of the Division to revise the surety bond form.
- With respect to the Division's regulatory revisions to the *existing* language of NRS 645B and NRS 645E, these are based upon the statutory changes to NRS 645B and NRS 645E, resulting from the enactment of by AB 468, effective October 1, 2017, which granted the Commissioner of the Division to revise the provisions governing exemptions for certain entities from requirements for licensures as a mortgage broker or mortgage banker (the Division, proposes that a person be required to obtain a license if they provide additional activities such as solicitation of business for the activities of a mortgage broker, or the activities of a mortgage banker or arranging a mortgage loan secured by real property that is not commercial property).
- With respect to the Division's regulatory revisions to the *existing* language of NRS 645B and NRS 645E, these are based upon the statutory changes to NRS 645B and NRS 645E, resulting from the enactment of by AB 468, effective January 1, 2020,
 - Eliminated the distinction between mortgage brokers and mortgage banker by creating a new term "mortgage company" and the mortgage agent term has been replaced by the term "mortgage loan originator;"
 - The mortgage companies follow the provisions related to mortgage broker when applying for and holding a license;
 - The provisions relating to violations by adding that an order imposing discipline and the findings of facts and conclusions of law supporting that order are public records; and
 - The provisions of the law that applied to mortgage bankers are repealed as redundant.

 - e. Adds to the provisions relating to violations by that an order imposing discipline and the findings of facts and conclusions of law supporting that order are public; and
 - f. Repeals as redundant the provisions of the law that applied to mortgage bankers in accordance with Assembly Bill 468 of the 2017 Nevada Legislative Session, effective January 1, 2020.
- 4. Workshop review and discussion of proposed regulations.
- 5. Public Comment may limit public comment to 5 minutes per speaker.
- 6. Adjournment.

Agenda items may be taken out or order. Two or more agenda items may be combined for consideration. An item may be removed or discussion on an item may be delayed at any time.
