In particular, the Division seeks input from interested persons to assist in its determination as to whether or not the proposed regulations are likely to impose a direct and significant economic burden upon a small business, or restrict the formation, operation, or expansion of a small business in Nevada.

Members of the public may make oral comments on the proposed regulatory changes at this meeting. Persons wishing to submit written comments, testimony, or documentary evidence prior to the meeting should submit such on or before **June 12, 2024**, by contacting the Division at its Las Vegas office either by (1) mailing in their request to 3300 W. Written submissions should identify the particular chapter(s) of the NAC or NRS subject of concern with respect to the proposed regulations (NAC 645B and NRS 645B).
