**NOTICE OF INTENT TO ACT UPON A REGULATION
NOTICE OF HEARING FOR THE ADOPTION AND AMENDMENT OF
REGULATIONS OF THE
DIVISION OF MORTGAGE LENDING**

The Commissioner of the State of Nevada, Division of Mortgage Lending (the "Division") will hold a public hearing **at 9:00 a.m. on October 2, 2025**, to receive comments from all interested persons regarding the adoption of regulations that pertain to chapter 645B of the Nevada Administrative Codes ("NAC") and Nevada Revised Statutes ("NRS"). The following information is provided pursuant to the requirements of NRS 233B.0603:

1. Purpose and need of the proposed regulation.

This public hearing concerns the Division’s proposed regulations regarding working at remote locations. Senate Bill 355 (“SB 355”) passed during the 2023 Nevada Legislature, amending NRS Chapter 645B to include NRS 645B.058, which permits a mortgage company to authorize work at a remote location, sets forth certain requirements for any such remote work, and requires the Commissioner to “adopt regulations governing the conducting of the business of a mortgage company at a remote location.” The proposed regulations were drafted to comply with this requirement. The Division proposes to amend NAC 645B to accommodate the changes in Nevada law and ensure the Division’s regulations are written clearly and concisely, are not duplicative or unnecessary, and will protect the health and welfare of Nevada without unnecessarily burdening business activity. Specifically, the proposed regulations provide provisions that apply to mortgage companies and mortgage loan originators regarding work from a remote location.¹

2. Obtaining the text of proposed regulations prepared by the Legislative Counsel Bureau.

A copy of the revised proposed regulations for adoption, LCB File No. R190-24, is attached.

Access to text of the revised proposed regulations prepared by the Legislative Counsel Bureau pursuant to NRS 233B.063, may be obtained by visiting the website of the Nevada Legislature at <https://www.leg.state.nv.us>, hovering over the term “Law Library,” hovering over the term “Nevada Register.” Clicking upon the term “Browse,” and then clicking upon the term “Numerical Index” appearing under the Category “2024 Regulations.” Access may then be obtained by simply scrolling down the list of LCB File Numbers to seek “R190-24” and then specifically clicking upon the designation “R190-24P.” Alternatively, the language can be found by performing a “search” function specifying “R190-24P” and then clicking upon the reference to R190-24P as specified.

3. Estimated economic effects on the regulated business and the public.

The Division does not foresee any economic effects of the proposed regulations (whether immediate or long term) to the business of a mortgage company or mortgage loan originator or to the public.

The Division reviewed and considered eleven email responses received from the solicitation of the proposed regulations. See the Small Business Impact Statement for the concerns received and how the Division responded to these concerns.²

To date, the Division has not received any other written or oral comments that would indicate that the regulations will have any economic effect, either adverse or beneficial, upon such businesses.

4. Methodology used to determine the impact of the proposed regulation upon a small business.

On April 26, 2024, the Division posted its proposed regulations on its website and made email notification to its licensees (a total of approximately 9,257 recipients), requesting comments and input concerning whether its regulatory proposals were likely to impose a direct and significant economic burden upon a small business subject to NAC 645B and NRS 645B. The Division received a total of eleven written responses by May 28, 2024. See the Small Business Impact Statement for the concerns received and how the Division responded to these concerns.

The Division repeated its request for public comments in this same manner on May 31, 2024, when it issued its Notice of Public Workshop & Agenda concerning the proposed regulatory changes to NAC 645B and NRS 645B on its website and made email notification to its licensees (a total of approximately 9,383 recipients). As issued on May 31, 2024, these materials were also posted to the Nevada Public Notice Website at <https://notice.nv.gov> and the Nevada Legislature's web page for administrative regulation notices at <https://www.leg.state.nv.us/App/Notice/A/>, as well as at the following Nevada office locations: The Division's office in Las Vegas, the Nevada State Business Center in Las Vegas, the Department of Business & Industry in Carson City, and the Nevada State Library & Archives, in Carson City. The Division received no new written responses by June 12, 2024.

The Division repeated its request for public comments in this same manner on June 3, 2024, when it issued its Amended Notice of Public Workshop & Agenda concerning the proposed regulatory changes to NAC 645B and NRS 645B on its website and made email notification to its licensees (a total of approximately 9,371 recipients). As issued on June 3, 2024, these materials were also posted to the Nevada Public Notice Website at <https://notice.nv.gov> and the Nevada Legislature's web page for administrative regulation notices at <https://www.leg.state.nv.us/App/Notice/A/>, as well as at the following Nevada office locations: The Division's office in Las Vegas, the Nevada State Business Center in Las Vegas, the Department of Business & Industry in Carson City, and the Nevada State Library & Archives, in Carson City. The Division received no new written responses by June 12, 2024.

The Division repeated its request for public comments in this same manner on June 24, 2024, when it issued its Second Amended Notice of Public Workshop & Agenda concerning the proposed regulatory changes to NAC 645B and NRS 645B on its website and made email notification to its licensees (a total of approximately 9,395 recipients). As issued on June 24, 2024, these materials were also posted to the Nevada Public Notice Website at <https://notice.nv.gov> and the Nevada Legislature's web page for administrative regulation notices at <https://www.leg.state.nv.us/App/Notice/A/>, as well as at the following Nevada office locations: The Division's office in Las Vegas, the Nevada State Business Center in Las Vegas, the Department of Business & Industry in Carson City, and the Nevada State Library & Archives, in Carson City. The Division received no new written responses by July 15, 2024.

The public workshop was conducted on July 22, 2024, as scheduled and properly noticed, with only three members of the public in attendance in person and 16 people appearing remotely via WebEx. The Division addressed concerns raised regarding shared workspace. Other people commented about their support for the proposed regulations.

5. The estimated cost to the agency for enforcement of the proposed regulation.

The Division does not anticipate incurring additional costs for the implementation and enforcement of the proposed regulations. The agency will receive less fees by adopting these new regulations.

6. Overlap or duplication with regulations of other state, local or federal agencies.

None known at the time of this posting.

7. Identification and description of federal law that requires the proposed regulation.

None.

8. Summary of less stringent federal regulations that regulate the same activity.

None known at the time of this posting.

9. New fee established or increase to existing fee.

The proposed regulations do not establish a new fee or increase any existing fee.
